Subject: - First Information Report

Sir,

That on 22.05.2021 at 1700 hours a credible source information was received from a reliable source information that one individual identified as Nar Bir Baraily, a permanent resident of Marchak, East Sikkim is in possession of brown sugar and selling the same to his prospective buyers even during lockdown from his house.

Accordingly, self along with the team proceeded to the residence of the alleged Narbir Baraily, the search of the place and person was conducted as per the provision laid u/s 100 Cr.PC duly complying the procedure, in the presence of two independent witnesses Bijay Pradhan, 41 yrs., s/o D.S Pradhan, r/o Marchak, East Sikkim and Saran Das Sadhu, 40 yrs, s/o Hari Das Sadhu, r/o Marchak and Gazetted Officer, Dy.SP Prakash Subba SDPO/Gangtok, after maintaining proper formalities. The House Search Warrant could not be obtained due to late hour and the court being closed due to weekend holiday and there was possibility of the alleged person disposing off with the contraband substances. During search of the house the alleged person Nabir Baraily, 38 yrs, s/o Lt. Purna Das Sadhu, r/o Marchak and Praveen Gurung, 25 yrs, s/o Tirtha Bdr Gurung of Adampool were present inside the room. The body search of alleged Narbir Baraily led to the recovery of following contraband substances.

1. 12 Nos. of small pouches of blue coloured plastic containing brown coloured powder suspected to be brown sugar weighing 1.970 grams including the plastic pouches. The same was kept inside the left front pocket of his black coloured jogger worn by him.
2. A white coloured plastic containing marijuana weighing to 9.980 grams kept inside the left back pocket of his black coloured jogger.
3. A brown coloured Puma wallet containing cash amounting to Rs. 9,750/- collected through sale proceed recovered from right back pocket of his black coloured jogger.
4. One paper tube with suspected brown sugar residue.
5. One Rs 1 coin with suspected brown sugar residue.
6. Two small pieces of black coloured plastic.
7. Original Aadhar card of Narbir Baraily.

Besides that the following incrementing articles used in sale of contraband substances were recovered from the residence of the alleged person.

8. One digital weighing machine used to measure the quantity of brown sugar
9. 2 Nos of mobile phones OPPO A1K with sim no 9339437720 and LAVA used for mode of communication with prospective buyers.
10. 42 nos of blue coloured pieces of plastic used for wrapping brown sugar
11. Cash amounting to Rs. 7000/- collected through sales proceeds was kept in the locker of godrej.

Further, he failed to produce valid medical prescription/license for sale of the same. Accordingly, the same were photographed, packed and sealed in presence of witnesses and Gazetted Officer and seized under the provision laid u/s 100 CrPC under a memo duly maintaining the legal procedure. Subsequently, a Ranipool PS case FIR No. 23/2021 dated 22/05/2021 u/s 21/22/27 NDP5 Act, 1985r/w u/s 34 IPC has been registered against Nar Bir Baraily and Praveen Gurung on Sue-moto basis and the case is endorsed to SI Deepa Sharma for investigation.

I the undersigned self night duty officer SI Nikhil Cheltra would like to beg to state that on the information received from 32 No. out post duty personnel NIK 020587 Kharka Bcto. Baramilly via WT self proceeded towards spot 8th mile, near SSB camp NH 10 and conducted an enquiry wherein it was learnt that one mascopolo bus of forest pharmaceutical bearing registration NO. SKO1B 074 had met with an accident with one bajaj pulsar bike bearing NO. SKO1PB 0874 thereby causing major injuries to the bike rider. Accordingly, the bike rider was rushed at CRH Manipal Tadong for medical treatment from the spot. Subsequently, MLC supplied in regard of the bike rider who identified as Anil Das, SSB Constable, 8th mile SSB camp. It was further learnt that the bus was coming down towards forest pharmaceutical and the rider Anil Das was on his way to his duty at 8th mile SSB camp.

Hence, I am submitting this FIR for further course of action from your end please.
