Subject: First Information Report

Sir, As per your direction, self-visited old check post Rangpo and found one Sumo gold b/r no WB73E-9759 parked on the roadside at old bridge Rangpo check post well guarded by the duty personnel LNK Ongyal Bhutia of check post. On enquiry, it was found that the suspected passengers identified as 1) Rikesh Suji, 30 years s/o Late Sanjay Kr Suji r/o Pachay Samsing was found seated in the front row of the aforementioned vehicle in a suspicious manner along with one Robert Rai, 22 years s/o Dew Kumar Rai r/o Zoom, Soreng district, Sikkim with one grey colour bag placed in front of their seat. On enquiry with driver and other occupants, both had boarded the vehicle together from Siliguri junction carrying a bag. Thereafter, under the provision of section 100/165 CrPC, self-secured two independent witnesses namely I) Dulal Das, 43 years s/o Basanta Das r/o Champasari, naya Bazar, Siliguri, West Bengal and II) Vinod Kumar, 45 yrs s/o Late Uttam Shah r/o Rangpo, Sikkim. The alleged suspects were given an option u/s 24(1) of SADA 2006, wherein they opted to be searched in the presence of a Gazetted Officer. Accordingly, the undersigned requested SDPO/Rangpo, ASP Lall Bdr Chettri over WT signal to witness the search seizure of the alleged persons. On arrival of SDPO/Rangpo at the spot, I offered myself to be searched by witnesses in person duly preparing search memorandums and proceeded to search the suspects and their belongings. The search of duo suspects namely Rikesh Suji and Robert along with their belonging led to the recovery of contraband substances as mentioned under: i. 1548 nos of loose blue colour capsules printed Windlas Winspasm Forte packed in six different black colour polythene ( plastic contains: 284287292288273124 1548) and concealed inside a Grey bag with orange lining along with one white towel. ii. 10 nos of loose blue colour capsules, 06 were found inside the right side pocket of jacket and 04 Nos were found inside the right side pocket of Pant worn by Rikesh Suji. Since, the alleged persons were not able to produce any valid license under the Drugs and Cosmetics Act, 1940 or Sikkim Trade License Act nor the prescription of the qualified medical practitioner. Hence, the same were seized u/s 102 CrPC. for further needful action in presence of above named independent witnesses. The seized articles were photographed, packed and sealed in the brown cartoon in presence of above mentioned independent witnesses. At the time of search seizure procedure, both the alleged persons viz. Rikesh suji and Robert Rai also admitted that they had both travelled to Siliguri together and bought the above seized controlled substances worth Rs. 8000/- by contributing the amount. Hence, in light of above facts you are requested for further necessary legal action against alleged 1. Rikesh suji, 30 years s/o Late Sanjay Kr Suji r/o Pachay Samsing, Pakyong and Robert Rai, 22 years s/o Dew Kumar Rai r/o Zoom, Soreng district, Sikkim.



Sir, As per your direction, self-visited old check post Rangpo and found one SNT Bus b/r no SK-04B-0118 parked on the roadside at old bridge Rangpo check post well-guarded by the duty personnel NK Krishna Bdr. Chettri of check post. On enquiry, it was found that the suspected passengers identified as 1) Shiva Pradhan, 32 yrs s/o Dilip Pradhan and 2) Buddha Pradhan, 34yrs s/o Dilip Pradhan, both r/o Namli, Ranipool, Sikkim were found seated in the last row seats (27 28) of the aforementioned bus. On enquiry with driver and other occupants, both the above named suspects had boarded the bus together from Siliguri SNT junction. Thereafter, under the provision of section 100/165 CrPC, self-secured two independent witnesses namely I) Rajat Goyal, 28 years s/o Anil Goyal r/o Lall Market, Gangtok and II) Suraj Chettri, 36 yrs s/o Janga Bdr. Chettri r/o Bankim Nagar, Siliguri, West Bengal. The alleged suspects were given options u/s 24(1) of SADA 2006, wherein they opted to be searched in the presence of a Gazetted Officer. Accordingly, the undersigned requested SDPO/Rangpo, ASP Lall Bdr Chettri over WT signal to witness the search seizure of the alleged persons. On arrival of SDPO/Rangpo at the spot, I offered myself to be searched by witnesses in person duly preparing search memorandums and proceeded to search the suspects and their belongings. The search of duo suspects namely Shiva Pradhan Buddha Pradhan along with their belongings led to the recovery of contraband substances as mentioned under: 1) 07 small packets of plastic polythene (03- green, 02-white, 01- yellow and 01- Black) containing brown powdery substance suspected to be Brown Sugar having total weight of 6.22 grams recovered seized during body search of suspect Buddha Pradhan. 2) One Bus Ticket of SNT, Govt. of Sikkim bearing SI.No: 432992, with journey date: 28/11/2022, Passenger Name: B. Pradhan and Seat Nos: 27 28. Since, the alleged persons were not able to produce any valid license under the Drugs and Cosmetics Act, 1940 or Sikkim Trade License Act nor the prescription of a qualified medical practitioner hence, the same were seized u/s 102 Cr.PC. for further needful action in presence of above named independent witnesses and SDPO/Rangpo. The seized articles were photographed, packed, seized and sealed in a yellow envelope in presence of above mentioned independent witnesses and Gazetted Officer. At the time of search seizure procedure, both the alleged persons viz. Buddha Pradhan and Shiva Pradhan who are brothers also admitted that they had both travelled to Siliguri together for the purpose of buying brown sugar and bought the above seized controlled/contraband substances worth Rs. 9000/- by contributing the amount together. Hence, in light of above facts you are requested for further necessary legal action against alleged persons, 1) Shiva Pradhan, 32 yrs s/o Dilip Pradhan and 2) Buddha Pradhan, 34yrs s/o Dilip Pradhan, both r/o Namli, Ranipool, Sikkim.




