

Sub: Report on Vehicle accident

Madam,

That on 20.08.2021, at 1810 hrs. received a call book intimation from MO on duty, CHC Jorethang, South Sikkim stating that four persons namely Chatra Maya Rai (45 yrs/f), Namrata Subba (20yrs/f), Basant Subba (20 yrs/m) and Phurkit Lepcha(22 yrs/f) are brought at CHC with alleged h/o RTA at 5th mile Budang today at around 1630 hrs.

As directed by SHO/NBPS, self-conducted enquiry wherein it was found that on the same day at around 1630 hrs the vehicle (Maruti Van) b/r no. SK 01 PA 7096 driven by Basant Subba, age 20 yrs, s/o Harka Bahadur Subba, r/o Budang, West Sikkim plying from Budang, West Sikkim to Chumbung, West Sikkim had met with an accident near 5<sup>th</sup> mile Budang, West Sikkim. There were 3 other occupants namely 1. Chatra Maya Subba, age 45 yrs, w/o Harka Bahadur Subba, r/o Budang, West Sikkim, 2. Namrata Rai, age 20 yrs, d/o Santa Kumar Rai, r/o Namchi, South Sikkim, a/p Budang, West Sikkim, and 3. Phurkit Lepcha, age 22 yrs, d/o Dawa Lepcha, r/o Lingja, North Sikkim, a/p Budang, West Sikkim who had sustained serious injuries and were evacuated to CHC Jorethang for medical treatment. The driver along with other occupants was referred to District Hospital Namchi for further medical treatment wherein one of the victims Chatra Maya Subba succumbed to her injuries on the way to Hospital.

Further, proceeded towards the said spot where the accident had occurred wherein it was found that vehicle had gone off the road approx. 20 ft. in the Jungle area.

Sub: Report on Vehicle accident

Madam,

That on 20.08.2021, at 2100 hrs. received telephonic information from one Ct. Prem Tshering, Kaluk PS stating that a vehicle has met with an accident near Bompul, West Sikkim. As directed by SHO/NBPS, self-proceeded towards the said spot and conducted enquiry wherein it was found that on the same day at around 2000 hrs one vehicle (Maruti Alto) b/r no. SK 01 PA 6814 driven by Arpan Bista, age 27 yrs, s/o Man Dhoj Bista, r/o Heegaon, West Sikkim plying from Karfectar, South Sikkim towards Heegaon, West Sikkim had met with an accident near Bompul, West Sikkim. The vehicle had fallen down the road approx. 1500 ft. into the jungle. There were 5 other occupants namely, 1. Arun Kumar Bista, age 25 yrs, s/o Man Dhoj Bista, r/o Heegaon, West Sikkim, 2. Ram Kumar Bista, age 33 yrs, s/o Janga Bahadur Bista, r/o Heegaon, West Sikkim, 3. Bishnu kumar Bista, age 30 yrs, s/o Ratna Bahadur Bista, r/o Heegaon, West Sikkim, 4. Anand Kirketa, age 15 yrs, s/o Ishak Kirketa, r/o Accapara, West Bengal, a/p Heegaon, West Sikkim, and 5. Laxmi Pd. Bista, age 33 yrs, s/o Mon Bahadur Bista, r/o Heegaon, West Sikkim who had sustained serious injuries were evacuated to PHC Mangalbaria for medical treatment wherein Laxmi Pd. Bista was declared brought dead by MO on duty. The driver along with other occupants was referred to District Hospital Namchi for further medical treatment.


