**Sub: First Information Report.**

Sir,

A credible source information was received stating that two known peddlers named Suren Rai of Salghari and Pemba Tamang of Masjid Line, Jorethang are in possession of huge quantity of contraband

found the suspects Suren Rai and Pemba Tamang at the house itself. Thereafter, I immediately secured the presence of two independent witnesses Pravin Rai (Panchayat) and Anthony Rai r/o Salghari, Jorethang. Further, suspect persons were given choice to be searched either in front of Magistrate or any Gazetted Officer, to which they wished to be searched in the presence of any gazetted officer. Accordingly, SDPO/Jorethang was requested to be available at the Spot which he agreed and appeared therein. Thereafter, I offered myself and search team viz. LNK Tika Ram Gurung to be searched by the suspects Suren Rai and Pemba Tamang and WCT Rina Bhujel to be searched by wife of Suren Rai named Kamala Rai then I proceeded to search the above named suspects and the house wherein the following articles were recovered:

- 1) Ninety- Nine (99) pouches of dry brown colored dust like substance wrapped in transparent paper pouch weighing 66.26 grams and suspected to be brown sugar concealed inside black and grey colored sock written SPORT and kept inside black colored backpack written 'a'.
- 2) Eight (08) no. of loose blue colored capsules written WINDLAS WINSPASMO kept and concealed inside green and yellow colored plastic written CITY GOLD MAGIC TEA.
- 3) One (01) number of white colored tablet inside brown colored tablet foil suspected to be Nitrosun-10, Batch no. NIL, Mfg Date NIL, Expiry Date NIL kept and concealed inside green and yellow colored plastic written CITY GOLD MAGIC TEA.

Accordingly, the recovered contraband & narcotic/psychotropic substances were photographed, seized, packed and sealed in the presence of aforementioned independent witnesses.

Management Act 2005 and Sikkim Public Health and safety (COVID-19) Regulation 2020 and the National Directives for COVID- 19 Management(.)




