KFS 066 with T.P No. 14763 dated: 24.03.2021 Driver's Name Mr. Keshar bdr Manger was left from factory Mulukey to Melli depot on 24th march 21 around 2.50 pm.

But today morning I came to know the same vehicle had been in an accident near Padamchey village between Rorathang and Rangpo and entire consignment has been damage.

I would also inform you the road between Rorathang to Rangpo via Kumrek is not permitted to transport vehicle due to poor road condition. Therefore same route has been diverted through Padamchey. On enquiry this incident happen in around 11.30 pm onwards on 24.03.2021

This is for your kind information and necessary action please.




