12. FIR Contents:

That on 06/05/2021 at around 1410 hrs received telephonic information from SI M.B. Tamang, In-charge Mamring OP stating that the duty personnel deployed on Naka Duty at Mamring Bridge has intercepted one person at Mamring Bridge, South Sikkim and is suspected to be in possession of contraband substance.

I, therefore, immediately rushed to Mamring, South Sikkim and found the above suspected person Birkha Bahadur Tamang, age 27 yrs, s/o Passang Tshering Tamang, r/o Turung-Kritipur, South Sikkim detained by Mamring OP Police personnel at Mamring Bridge, South Sikkim. Subsequently, he was given an option u/s 24(1) of SADA, 2006 for personal search in presence of two independent witnesses namely 1. Bikash Kharel r/o Mamring, South Sikkim and 2. Tara Gurung, r/o Mamring South Sikkim wherein he opted to be searched in presence of Gazetted Officer. Accordingly, service of Shri, Kessang Dorjee Bhutia, SDPO/Namchi was availed who arrived at Mamring Bridge around 1640 hrs. The above named suspected person was then searched in the presence of Shri, Kessang Dorjee Bhutia, SDPO/ Namchi and two independent witnesses of the locality namely 1. Bikash Kharel r/o Mamring, South Sikkim and 2. Tara Gurung, r/o Mamring South Sikkim.

Prior to conducting search of the suspect I, submitted before him for my body search duly preparing a memorandum of search in presence of two independent witnesses. The search of above named suspected person was then conducted duly fulfilling lawful norms and to his satisfaction in the presence of two independent witnesses wherein following articles were recovered from his possession:

One Red carry bag containing: -



On the basis of above facts and seizure Namchi PS Case no. 15/2021, dated 06/05/2021, u/s 9(b)/14 of SADA Act, 2006, r/w Sec. 9 (1) (b) SADA Amendment Act, 2017 registered on suo moto basis against Birkha Bahadur Tamang, age 27 yrs, s/o Passang Tshering Tamang, r/o Turung-Kritipur, South Sikkim and endorsed to SI Kunchok N. Wangdi for investigation.

13. Action taken: Since the above report reveals commission of offence(s) vide Entry No. 2, the case is registered and investigation is taken up/directed* SI Kunchok N. Wangdi to take up the investigation/transferred to PS _____ on account of jurisdiction.
