Sir,
That on 15/07/2021 at around 2340hrs while I was conducting routine checking of vehicles at Melli checkpost, a vehicle b/n SK 05 D 0265 (Pickup) approached towards the check post from West Bengal side driven by Junned Alam (later identified) who was accompanied by one Ram Sundas (later identified) both residents of Namchi. As a part of routine duty when I started checking the vehicle the driver in a nervous state tried to convince me that there is nothing inside the vehicle. Since both driver and occupant were seemingly intoxicated, they started getting nervous which created doubt in my mind of some wrongdoing. I frisked the two aforementioned persons however no incrementing items could be recovered from their possession. Due to odd hours and ongoing lockdown I could not afford to waste any more time as such I secured two independent witnesses namely Rajen Kharka and Tashi Tamang and proceeded with the search of the vehicle as per the provisions laid down u/s 100 CrPC. Upon thoroughly checking the vehicle I recovered one transparent plastic pouch containing sticky brown coloured substance suspected to be brown sugar concealed inside the steering wheel. The recovered substance when weighed on a digital machine amounted to 58.69 gms in total. Subsequently, the item recovered was seized, sealed and packed in brown envelope in presence of aforementioned witnesses at the check post along with the vehicle involved and its documents.
