Sir, Most respectfully, I the undersigned would like to state that my natural elder brother, Mr. Bhim Bahadur Subba age about 46 years s/o Late Hangcha Lal Subba r/o Lower Rinchenpong, Namchak, west Sikkim was deadly assaulted near the zeal church at around 6.30 pm on 11.04.2021 (Sunday) by one shaktiman Rai of zeal west Sikkim as stated verbally to me by my elder brother, Bhim Bahadur Subba on his way to his residence. Further, the injuries in his body and his condition was so grave which seems that the intantion behind the assault was to kill him (attemp to murder). Owing to the critical health condition of my elder brother, he was immediately sent to Namchi District Hospital with family member for medical treatment. Hence, under the circumstances, I would like to request to initiate legal action as per law please
