I the undersigned would like to bring it to your kind concern that today on 18/11/2022 at around 0700 hours when I along with Village Guard Karma Gyatso Bhutia were on patrolling duty at Phodong Bazar, we received an information from one truck driver Arun of Phensong that a vehicle had met with an accident along the Highway at Sai Gaon, Phodong. Accordingly, we proceeded towards the accident spot at Sai Gaon, Phodong and found one Alto taxi vehicle bearing registration no. SK 01 T 7550 had met with an accident by falling down to the jungle below the road. It is learnt that the accident vehicle was driven by one Laxuman Darjee, who was also at the accident spot during our visit. On inquiring with the driver, he informed that he was travelling alone in the vehicle and the accident had occurred last night (17/11/2022) at around 2130 hours while he was travelling from Kabi towards Zero, Rangrang. The driver Laxuman Darjee has sustained injuries in his body and the vehicle is also badly damaged in the accident. Accordingly, I would like to lodge an FIR upon the matter for necessary investigation of the case.
