Respected Sir,

I, ASI Tsheten Namgyal Bhutia, IC/Bojoghari would like to inform 1145 hours I have received a WT signal from duty officer, Sadar Police Station, Gangtok mentioning that an RTA has taken place at Mandir Dara, Phenengla and directed me to conduct inquiry. As directed I along with beat X duty personnel HC Karma Gyatso Bhutia and L/NK Dup Tshering Bhutia rushed at the spot and learnt that today i.e. 22/11/2022 at around 1130 hours one taxi (Alto 800) b/r No. SK01T 8314, driven by one Chandra Kumar Pradhan had tumble down approximately 300 ft. below the road at Mandir Dara, Phenengla. The alleged driver Chandra Kumar Pradhan has died at the spot and one lady passenger namely Geeta Tamang, 58 yrs, r/o Soreng, a/p Syari has sustained injury. It is also learnt that the two other female passengers namely Tshering Yanzom Bhutia, 42 yrs, r/o Upper Sichey and Hima Yalmu Sherpa, 42 yrs, somehow managed to jump from the vehicle and escaped the accident.

Further, with the help of locals the female victim Geeta Tamang was evacuated and sent to STNM hospital along with two other victims Hima Yalmu Sherpa and Tshering Yanzom Bhutia for medical attention. The dead body of alleged driver Chandra Kumar Pradhan was forwarded to mortuary house of STNM Hospital for further necessary action.

Hence, you are requested to initiate necessary action as per law.






