Respected Sir,

This is to inform you that on 01.01.2021 at around 0200 hours, the duty personnel deployed at Beat 1 viz. NK Ashok Kr. Gurung and Ct. Sailendra Chettri deployed at Upper Bazar Rangpo, informed over WT Signal that one **Uttam Rai, 25 yrs, s/o Sajjan Rai, r/o Kasim, Mansong, West Bengal** had been brought at PHC, Rangpo by Shri Bhim Chandra Subba with the history of Road Traffic Accident near Mining area along NH-10 highway.

Accordingly, the undersigned was directed to conduct an enquiry by SHO Rangpo PS. During my enquiry, I visited the Place of occurrence located at Mining, Rangpo along NH-10 highway where the motorbike bearing registration no. WB34Y/5533 was found lying at the accident spot. Photographs of the PO were taken. Thereafter, PHC Rangpo was visited and the patient had been referred to higher centre for further medical treatment after initial treatment as the condition of the patient was critical as reported by the Medical Officer, PHC Rangpo. However, the guardians of the patient had decided to shift the patient to District Hospital, Kalimpong. Further inquiry into the matter revealed that rider Uttam Rai was a lone rider on the said motorbike at the time of the accident and he was proceeding from Chanatar, Rangpo towards his rented residence located at Mamring after attending a New Year Party. The accident took place at around 01:30 hours as per the statement for Shri Bhim Chandra Subba who had been riding behind the motorbike b/r no. WB34Y/5533 on a different motorbike and had witnessed the accident.

As such, I am submitting my enquiry report for further legal action against the above mentioned rider, **Uttam Rai.**

This is to inform you that as per your direction self along with police team had proceeded to the Rangpo-Rorathang road near Sikkim Distilleries Ltd.(SDL), Rangpo for enquiry on the accident of one utility vehicle bearing registration number SK01D/3364.
