Respected Sir,

As per your direction self conducted an enquiry on a call book intimation received from MO on duty Dr.Rosina Bassnett, District Hospital Gyalshing, stating that a patient viz. Alta Raj Limboo, 30yrs, r/o Khechuperi, West Sikkim is brought to emergency ward with alleged h/o physical assault at his residence at around 7:30 pm on 17/11/2022.

On my enquiry it was revealed that today on 17/11/2022 at around 1930 hours the victim Alta Raj Limboo had verbal spat with his wife Choden Lepcha over trival issue wherein they both entred into physical fight. During the fight the victim wife Choden Lepcha suddently assaulted the victim with a knife on his left chest following which he sustained deep stab injury. As per the MO the victim is reported to have consumed alcohol. He was then immediately evacuated to District Hospital Gyalshing by the locals and his family members for medical treatment. Now the victim is being referred to STNM Hospital for better management and for opinion to injuries sustained.
