Sir,

This is to inform you that today about 1639 hrs when LNK Jit Bdr Lohar deployed at Melli Checkpost was conducting checking of incoming and outgoing vehicles and persons at Melli check post, he intercepted a vehicle Br/No SK 02 Z 0213 (Xylo) driven by one Sumit Chettri (Khadka) and boarded by Rikesh Chettri who were entering check post through West Bengal side. During routine questioning the abovementioned driver started getting nervous and his body language created doubt in his mind of some wrong doing. Accordingly, the duty personnel frisked the body of driver wherein he recovered substantial quantity of contraband capsules from his possession. Subsequently, as per your direction, I visited the check post wherein I found driver Sumit Chettri( Khadka), 30yrs, s/o Padam Prasad Chettri, r/o Timburbung, District Soreng well-guarded by the duty personnel. Thereafter, without wasting any time I secured two witnesses namely (i)Damber Kumar Basnett and (ii) Charles Lepcha and appraised him about his right to be searched either in presence of Magistrate or Gazetted officer as per the provisions laid down u/s 24(2) SADA. Therein he desired to be searched in presence of Gazetted officer. Accordingly, I secured the presence of DySP Kessang G Bhutia, SDPO Jorethang Sub Division who at that point of time was present at the checkpost. Prior to search I offered myself to be searched first duly complying with all legal formality. During search 117 numbers of loose blue capsules printed Windlas Winasmasmo Forte packed in light green transparent plastic was found concealed inside his underwear. Further 11 loose blue capsules printed Windlas Winspasmo Forte was found inside the left pocket of pant worn by him. In addition to contraband recovered following items were also recovered from his possession

1.One Samsung Galaxy J7 NXT mobile phone (IMEI NO

2.Black

356411095872171/356412095872179) with sim card Br/No 9083470456

coloured mens wallet (Levies) containing cash Rs 480/-

3 Driving Licence of Sumit Chettri(Khadka) bearing no SK 02 2012 0009302

In continuation to search, I also searched the involved vehicle in anticipation that he might have concealed some more contraband substances inside the vehicle. However, nothing incriminating could be recovered from the said vehicle. After the recovery the driver was asked to furnish the medical prescription for the recovered items which he failed to provide. Consequently, on completion of search, I seized, packed and sealed the items mentioned above along with the involved vehicle, ignition and its relevant documents in presence of the above mentioned witnesses. Further it is pertinent to mention that nothing incriminating could be recovered from the possession of occupant Rikesh Chettri.

As such, I am submitting this report for your information and further necessary action please.

Sir,

This is to inform you that today about 1731 hrs when LNK Jit Bdr Lohar deployed at Melli Checkpost was conducting checking of incoming and outgoing vehicles and persons he intercepted a daily service vehicle (Rinchenpong to Siliguri service) bearing No. SK 06 J 0140 (Force) driven by one Puran Baraily boarded with six passengers. Accordingly as a part of routine checking when he questioned the driver and the occupants present inside the vehicle one of the occupant namely Sanshad Rai of Nandugoan who was seated in the extreme right of second seat which was initially recorded as middle of second seat started getting nervous. Looking at his body language the duty personnel doubted of some wrong doing. After which he frisked his body wherein he found few contraband capsules on the front pocket of jeans worn by him. Further on checking his sky blue coloured bag pack placed underneath the seat where he was seated huge files of contraband capsules were recovered. Subsequently, as per your direction, I visited the check post wherein I found driver Sanshand Rai, 27yrs, s/o Lt Aitay Rai, r/o Nandu Goan, District Namchi (later identified) seated inside the vehicle well-guarded by the duty personnel. Thereafter, without wasting any time I secured two witnesses namely Puran Baraily(Driver of involved vehicle) and Gopi Lal Mukhia (occupant of the vehicle) and appraised him about his right to be searched either in presence of Magistrate or Gazetted officer as per the provisions laid down u/s 24(2) SADA,2006. Therein he desired to be searched in presence of Gazetted officer. Accordingly, I secured the presence of DySP Kessang D Bhutia, SDPO Jorethang Sub Division who at that point of time was present at the checkpost. Prior to search I offered myself to be searched first duly complying with all legal formality. During search of his possession one used file of Windias Winspasmo Forte totalling 03 capsules having batch no B/No WPS 22031, MFG/EXP Date June 2022 May 2024 were recovered from left pocket of black jeans worn by him.

In addition to contraband recovered following items were also recovered from his possession  
1. One VIVO Y16 mobile phone (IMEI NO 861861068270332/00) with VI sim card Br/No 8436450400  
2. Cash amounting to Rs 320/-  
3. Blue coloured cigarette lighter printed HIYAANSH.  
4. NAVY CUT cigarette packet containing three (03) cigarettes.

In continuation to search, I also searched his sky Blue/Purple coloured bag pack printed 561vb American Tourister which was placed underneath the seat wherein 71 files of Windias Winspasmo Forte capsule totalling 568 capsules having batch no B/NO WPS 22031, MFG/EXP Date June 2022 May 2024 were recovered. After the recovery Sanshad Rai was asked to furnish the medical prescription for the recovered items which he failed to provide. Consequently, on completion of search, I seized, packed and sealed the items mentioned above in presence of the above mentioned witnesses. Further it is pertinent to mention that details of seizure and exhibit marked have been mentioned in seizure memo prepared.

As such, I am submitting this report for your information and further necessary action please.


