That on 10/08/21 at around 0900hrs received a telephonic information from HC 302 Bhuvan Chettri of Legship O.P, West Sikkim stating that one vehicle B/R No. SK-OV-P-8272 (Black coloured Espresso) has tumbled below the highway around 70 feet to another adjoining road located at Sagberi, West Sikkim which leads towards NHPC Power Plant. During the accident the unknown driver along with one occupant has succumbed to their injuries on the spot.

Armed 1815 hrs SI. Rajeev Mukherjee around 1330 hrs a telephonic information was received from Nari Badi Rai (local panchayat), S/o-Aita Man Rai s/o-Zeel-Prattar, West-Sikkim, that his elder sister Meera Rai, 45 yrs, w/o-Nan Tshering Lepcha of same place had gone to Reshi bazaar on 08/08/2021 and did not return back home. On 09/08/2021 around 1230 hrs she was found dead in the jungle of Zeel Prattar, W/Sikkim and is suspected to have fallen from the old foot path located approx 100 ft above the PO.

Accordingly, Kaluk PS UD Case No - 08/2021, Dt: 09/08/2021, U/S-174 CrPc was registered and enclosed to him for investigation. During the course of investigation the PO located at Zeel-Prattar inspected thoroughly and legal formalities were completed in presence of relatives and independent witnesses. Inquest over the dead body of deceased Meera Rai was conducted and forwarded for Post Mortem Examination to STNM Hospital, Gangtok. Further, today the Post Mortem Exam Embalming Certificate of deceased Meera Rai was received where in it is opined that the Provisional Cause of Death ascertained as per Autopsy is Asphyxia as a result of strangulation - Homicidal in nature by Dr. O.T. Lepcha Chief Consultant - Gen - HOD, Department of Forensic Medicine STNM Hospital, Gangtok
