12. First information contents (पहली सूचना का सामग्री):

To: The Station House Officer, Rhenock Police Station, East Sikkim 737123 Date: 01/02/2021 Subject: Complainant reporting sexual exploitation in pretext of marriage, abduction, forced trafficking, cheating and threatening Dr. J. Nita Gai, D/o Ram Narayan Gai, R/o Singtam Zangar, East Sikkim would like to lodge his complaint against one Ashish K. Agarwal alias Ronak Agarwal (S/o: Kamlesh Agarwal), R/o Khairpura, Siliguri and his accomplices Kamala Agarwal (mother of Ashish K. Agarwal) Ranu Agarwal (Sister of Ashish K. Agarwal) and Nitesh Agarwal (husband of Ranu Agarwal) regarding sexually exploiting me, cheating, abducting and being into forced sex trafficking, threatening to take my life and with other dire consequences. It had all started in the year 2018 wherein I had happened to meet this person named Ashish K. Agarwal alias Ronak Agarwal on a Social Networking Site. He was at that time living with his relatives in Rhenock, East Sikkim and I was studying in Rhenock Government College. We used to have casual chats and conversation, but slowly we happened to develop a love relationship. He had said that he loved me truly and promised to marry me and very soon he would talk to his parents about the same. I felt happy and agreed to his proposal. Thereafter he began to ask for sexual favours, initially I denied but he would get agitated and would say that he has already talked to his parents about our marriage and why would I be reluctant, if I have no trust him then he would leave me. Since I loved him the fear of his leaving me drove me into sexual contact with him. Thereafter he continuously started to take sexual favours from me, and slowly after having with my trust began to make recordings of our intimate actions. This way two years passed by until the year 2020 and I was also at the verge of completing my studies at Rhenock. I would often remind him about our marriage and would ask him to make me have conversation with his parents, but he would often make excuses and tell some other day. It was in April, 2020 when we were at the covid-19 locked down period he denied to marry me and continue our relationship any further, he told me that he had only wanted me for pleasure and time pass, and he had no intention of marrying me. In the year 2019 he had already shifted to his house at Siliguri. His statement completely shattered me and broke me into pieces. I was depressed thinking my life had been ruined, as a result I had attempted suicide twice which Singtam Police Station is well aware of. The then SHO of Singtam PS had called an NGO and I had undergone counselling session as per my guardians wish, as my guardians had thought it was the matter of love and affair only. Thereafter I decided to take a firm stand against this situation and go against Ashish Agarwal and his family for ruining my life, bright future, career, my hopes and stole all my dignity, that I am not a time pass material for someone. Thereafter in the middle of the lock down period I decided to go to Siliguri and talk to his family and relatives about his deeds, I stayed at my friends place and thereafter I went to the house of Ashish K. Agarwal at Khairpura, and narrated the story to his parents. To my astonishment I found out that everyone in his family his mother, Sister, brother-in-law above named were aware of this fact, and rather than listening to my grievance they tortured me both physically and psychologically, yet I did not give up and told them that I would now take legal recourse for these actions and appeal all. Again, to my dismay they all started to abuse me and threatened by saying that they would make my objectionable videos and pictures go viral in the social medias and would ruin my life completely if I happened to seek for legal help. It was so disheartening to know that Ashish Agarwal and his accomplices including his mother were well aware of those objectionable videos and pictures that Ashish had recorded while we were having intimate relationship in the past years, and every member in the family had seen it. They further threatened me by saying that if I do not stop or try to do anything against their reputation, they have contacts with underworlds of the red light area in Khairpura and they will sell me for a good ransom and nobody would ever know about it, thereafter I became fonder on my stand and decided to bring all of them to justice while staying in Siliguri. They might have employed some persons to keep a watch over my activities or movement, but on 12th July, 2020 Ashish Agarwal along with his sister Ranu Agarwal and her husband Nitesh Agarwal abducted me from Street Smart Honda Showroom area and took me to the red light area in Khairpura, they beat me up badly and handed me over to some unknown person of the said red light area, however I managed to flee from the clutches of the said person and in haste I happened to enter some unknown persons house randomly and sought for their help. They called the women's police station nearby and some female police personnel came to my rescue, and I narrated the whole incident to them. They took me to the Station and called for my guardian, however they did not register any case and advised to get it registered from Sikkim taking into consideration my safety, I stayed the night and the next day I left. Thereafter I came to Sikkim, but I could not make a complaint because of the apprehension that the reputation of my family would come to stake. But despite of all of these Ashish Agarwal and his accomplices actions did not stop. They would often harass me over phone and threaten to make my nude videos and pictures go viral. Not only me but now they have started to harass my family members as well including my married sister. They are openly threatening us by saying that this things are too big just for
