This is to inform you that on 14.06.2022 at around 07:30 hrs. received - telephonic information from Mr. Lema Ongela 18th mile PP under Sherathang CP/PS stating that landslide occurs at 18th mile near Maule Army Transit Camp & AL Road construction. Company has loaded and debris falls into the mess room result in which some of the labours were trapped under the debris.

OFFICER-IN-CHARGE OF POLICE STATION

During the course of action, the rescue operation was conducted with the help of Army/Town/Local. Two labours identified as 1. Sanbattel Tamang, age 23 yrs of Bhatle Loh. Tamang, of Bhatkani, Gumbumby District; 2. Namori Anjan 21/1 male 18th mile, Dist. Cony 116; 3. Phunke Tshing Sentiya, age 48 yrs of Nara Tal Sentiya of Bhatulapang, west Kanang 21/1 male, 14th mile Dist; Cony 116 were conveyed to Army hospital at 18th mile and provided them a medical aid and later they were referred to STMS hospital one labour identified as Kalin Tamang, age 35 yrs of Kamesa Tamang of 111, Lower Bhatulapang AS & PS: Bhatulapang, west Kanang, Ananchal Pradesh 21/1 male 18th mile Dist.

INFORMATION'S STATION:

Cony 116 was found under debris in unconscious condition. The labour was carefully extracted from there and immediately taken to Army hospital on reaching hospital all efforts and measures for the doctor declared him

dead. Further the inquest on the deadbody was conducted in presence of witnesses and the deadbody of the deceased was forwarded for Postmortem at STMS hospital for the cause of occurrence was visited and examined thoroughly. witnesses were examined and recorded their statement up to 181 CRP. Further the landslide affected area has been vacated and all the labours has shifted to safe location.



Sir,
we the undersigned would like to inform that we are the resident of 5th mile, J.N. Road and would like to inform you some following few lines.
As that Dhan Bdr. Subba aged about 40yrs s/o Lok Bdr. Subba was the resident of 6th mile JN Road District Chengal East 5th mile. He used to frequently visit 5th mile JN Road on regular basis to buy liquor and regular shops required on daily basis. As not seeing him around for few days, we decided to check about his whereabouts on 05th June 2022 at around 1400 hrs.
On reaching his resident, we found him lying dead on ground above his home. As soon as we saw him we decided to directly inform the police and reported to 3rd mile Police Checkpost and reported the whole incident at around 1450 hrs.
The above fact is true to the best of our knowledge and belief. we shall remain very
