

FIR against Suraj Sharma owner of vehicle number SKTR0467A. That on 23/06/2021 at around 1357 hr a telephonic information was received from PC personnel LNK Daya Ram Giri and HG Chetan Pradhan of Rhenock PS mentioning that they have intercepted one Maruti Celerio vehicle bearing registration number SKTR0267A along with its driver at Rungdung which is suspected of transporting some contraband substances in it. It was reported that further search of vehicle has to be carried out in order to ascertain the facts. Accordingly, self along with ASI Tenzing Bhutia, LNK Navin Mukhia, proceeded towards Rungdung for search and seizure of the said vehicle. Shri Motilal Pradhan, DySP, SDPO Rongli had been requested to be present at the spot for the said search. After my arrival at the said spot which is an open stretch of Rhenock-Rongli road along with two independent witnesses namely Nagendra Pradhan and Mahesh Kr. Soni, one vehicle bearing registration number SKTR0267A (Maruti Celerio) along with its driver who identified himself as Suraj Sharma, 35 yrs, s/o Lt. Kalicharan Sharma, r/o Rungdung, Rhenock, East Sikkim was found waiting for my arrival. Subsequently, DySP Shri Motilal Pradhan also arrived at the spot and the procedure for search and seizure was started. In the beginning the witnesses were asked to conduct searches of the police personnel carrying out search of the person and the vehicle and subsequently the suspect Suraj Sharma was intimated in writing seeking his willingness to be searched in presence of a Gazetted Officer or a Magistrate. The suspect mentioned that he would want to be searched in presence of a Gazetted Officer. Hence, his body search was conducted in presence of the aforesaid witnesses and a Gazetted Officer. However, no any contraband substances were recovered from his body. Thereafter, the involved vehicle was thoroughly searched and during the same, one black coloured plastic bag was found kept inside the boot of the involved vehicle in the spare tyre in which the following controlled /contraband substances were recovered and seized - (1) 7 files of Nitrosun 10 (containing 10 tablets in each file) bearing batch no AA38606, Mfg Date 04/2019 expiry date 03/2022, (2) 258 nos of blue-coloured loose capsules having SPASMODON, Windlas written on it. Accordingly, seizure of vehicle bearing registration number SKTR0267A (White coloured Maruti Celerio) along with its ignition key and its documents i.e. Tax invoice no. EW3712270, 06 pages of application for registration of the motor vehicle (form 20), Original invoice for recipient loyalty invoice number LYC2000305, Insurance policy no 23112038167775000000, vivo mobile phone bearing IMEI No 864706043686416, 864706043686408 along with SIM no 7407059796 (Airtel). The recovered controlled and contraband substances were seized, packed, sealed and labeled in presence of independent witnesses and G.O. The entire search and seizure started at 1410 hr and ended at 1455 hr. The search and seizure procedure were appropriately documented and photographed in presence of independent witnesses. The possession of contraband substances without medical prescription in large quantity is an offence under SADA Act 2006 and NDPS Act, 1985 and the aforesaid Suraj Sharma could not produce any medical prescription regarding the recovery of the same from his vehicle. 
