Sir,

It is to inform you that today around 1900-1930 hrs. I was proceeding towards my resident Hamling Village Kupup. On reaching Tuki Dasa I saw one vehicle bearing Regd No. SK-03-10028 (Mahindra Blazer) which had an accident resulting in which the vehicle went off the road approx. 100 feet below the road. I immediately went to the spot and with the help of other labourers evacuated the driver of the vehicle viz. driver of the vehicle Pasang Rinzing Sherpa of Kupup in Army M.I. Room located at Kupup.

At M.I. Room the medical attendant provide preliminary treatment however his condition worsen observing the situation he was referred to higher management, on reaching 15th Mile J. H. Road his health condition deteriorated accordingly he was taken to 317 Fd. Hospital located at 17th Mile wherein the individual succumbed to his injuries and M.O. of 317 Fd. Hospital declared him dead at 2330 hrs.

As such, FIR is being supplied for favour of your kind information and legal action please.
