That the same number has circulated my picture through whatsapp to different numbers which has also came to my daughters whatsapp number. That when I talked about it to my husband he keeps denying taking that picture and states that he has no idea about any of it. However it is clear to me that it was my husband who took my picture while changing the dress and with regard to the circulation of that picture I have no idea as to the mobile number and its registered owner. That due to said incident my dignity as a omen has been hampered and I am in stress about the same. Hence, it is my humble request your good self to kindly take necessary action and investigate the matter at the earliest possible and also take a legal action against the owner of mobile bearing Mobile No. 8653751811 who is circulating my picture.
