It is to inform you that today i.e 23/03/2021 at around 1930 hrs, one vehicle bearing no. SK02 P 1270 (Gypsy) which was reported to be driven by alleged driver Anmol Limboo (Uttarey Bazaar met with an accident near Singshore bridge while returning back to Uttarey from Bega, Dentam. The vehicle toppled down around 700 feet below the road. The alleged driver was accompanied by one Yadu Bir Chettri, 26 years, R/o Neyha-Manzee, South Sikkim A/p Uttarey Bazaar who succumbed to his injuries on the spot. The alleged driver also sustained severe injuries on his person have been evacuated to PHC, Dentam.


