Our company is working on the construction of Rhenock to Pakyong (NH717A) Highway and one of our stock yard is located at Rorathang, below Rorathang bridge, Near Murdathali, under Rhenock PS. I had received an information regarding theft of construction materials from the above-named stock yard since couple of days, but was unable to trace to them. However, today at around 0900 PM, I received an information from reliable sources stating that construction materials were being stolen from the aforesaid site. Therefore, I along with my other staff came to our stock yard and found out that 20mm stone chips were being loaded onto one truck bearing registration number SK07D/0184 along with the help of some other men. There were 6-7 persons involved in the said racket including the driver whom we can identify. Subsequently, on being caught they tried to attack us and our security officer but we managed to overpower and restrain them. Thereafter, I called up Rhenock Police Station and they were brought to PS. Therefore, it is humbly requested that necessary action may kindly be taken against the culprits involved in this stealing racket which was going on for quite some time. Thanking you.
