His white colour MI Bluetooth speaker. Further, it is reported that the unknown person has also withdrew Rs. 1300 by using his ATM on 03/08/2022 from SBI Account no. 35623859104. Accordingly, Soreng PS case FIR no. 17/2022 dated: 03/08/2022 u/s 457/380 IPC, 1860 is registered against unknown person and case endorsed to SI Anil Subba for investigation.

So I called my friend Nurbhar and we asked him to call out teachers and they informed it to police.
