Sir,  
I the undersigned would like to inform you that as per your direction self along with police team intercepted the vehicle(bus) bearing registration no. WB 73 C 4924 at Singtam near old bridge, East Sikkim on 05/02/2021 at around 1920 hrs on receipt of source information that three alleged persons namely Samir Rai, Marcus Rasaily and Thinley Tshering Rai were suspected to be in possession of contraband substances and were travelling towards Gangtok in the above mentioned vehicle from Siliguri, West Bengal.

As such I secured the presence of two independent witnesses i.e. Dipu Thakuri and Pappu Singh (bus driver and bus conductor of the above mentioned vehicle). Thereafter the above named alleged persons were supplied an appraisal letter in presence of witnesses wherein they consented on being searched in the presence of a Gazetted officer. As such SDPO/Rangpo was telephonically intimated to be present for search and seizure procedure of the alleged persons and on his arrival a written intimation letter was acknowledged by him. Self and L/NK Deepak Pokhrel were subjected to body search by the above named witnesses. Search conducted led to the recovery of one grey/black coloured bag printed "north face" from the possession of alleged Thinley Tshering Rai wherein two boxes of Windspasmo forte capsules containing 45 strips of windspasmo capsules(each strip containing 8 capsules each) totaling 360 capsules, 8 strips of windspasmo forte capsules (each strip containing 8 capsules each) totaling 64 capsules from the inner left pocket jacket of alleged Marcus Rasaily and 1 black plastic pouch containing 69 loose blue coloured capsules printed windspasmo windplas capsules recovered from the possession of alleged Samir Rai inside his right inner pocket of his jacket. Further, alleged persons failed to produce valid medical prescription of the above seized contraband substances on being asked to produce the same.

The recovered, suspected contraband substances were photographed, seized, packed and sealed in presence of Gazetted officer and aforementioned independent witnesses. Thus, requested for the necessary legal action.
