I NK 2375 Pema Ongchen Bhutia of 15th mile PP, East Sikkim would like to inform you that today around 1415 hrs one Prem Sharpa of 15th mile village, J.W. Road, East Sikkim appear at PP and verbally informed that his wife Mrs Binle Bhutia had committed suicide at their residence today.

Accordingly, self proceeded to place of occurrence OFFICER-IN-CHARGE OF POLICE STATION in 15th mile village, J.W. Road East Sikkim and found that Mrs Binle Bhutia aged 40yrs wife of Phungla South Sikkim A/P 15th mile village, J.W. Road, East Sikkim had committed suicide by way of hanging with the help of piece of bedsheet for the horizontal beam of the door.

Further enquiry revealed that the deceased was permanent resident of Phungla, South Sikkim and after getting married with Prem Sharpa (2nd husband) since 10 years back she had been residing at present address. Prem Sharpa is a mason working in Army Camp at 13th mile and the deceased was homemaker, at the relevant time of the incident she was alone at home since her husband went to his work.
