Respected Sir,

With due respect and humble submission I Ramesh Kr. Gupta elder brother of Suresh Kr Gupta who is a victim would beg to state your kindness, that my brother Suresh who used to take drugs, willing wanted to go to rehabilitation Center for which we approach Vicky Chettri (bhai), who is a social worker and helps people who wants to quit drugs. So on our request and permission he took Suresh and got him admitted for which we are thankful. He sat there as Suresh local guardian, on 22<sup>nd</sup> July 2021. As Vicky bhai was the local guardian, Vicky bhai called upon Suresh wife on 31<sup>st</sup> July that the centre had informed him about a small fight had happened in the centre. Again on 4<sup>th</sup> August his wife was informed through Vicky bhai that, Center had informed him that Suresh was been taken to Manipal hospital and his guardian should come. On getting to hospital we saw that Suresh was admitted to ICU in unconscious state. We saw that he had a deep cut above his eye brow, very deep bruises with wound in his buttock, deep cut in both legs. So seeing his state I feel that he was beaten there. He was admitted to Sikkim Rehabilitation and detoxification Society 32 No.

I request your kindness to kindly look into this matter and do the needful.
