Madam,
That on 16/06/2022 at around 1520 hrs received a telephonic information from LNK Neehnag Subba stating that he has intercepted Sonam Tashi Tamang and Niraj Rai at Pipaley Bazar, District Soreng, Sikkim and suspects them to be in possession of contraband substances.

As directed, self along with Police team immediately rushed to the said spot for enquiry wherein accused Sonam Tashi Tamang, age 26 yrs, s/o Raj Kumar Tamang, r/o Pipaley, District Soreng, Sikkim and Niraj Rai, age 21 yrs, s/o Lt. Govind Rai, r/o Legshep, Gyalshing District Sikkim, a/p Housing Colony, Jorethang was found in sitting position beside the road. I examined them and strongly suspected to be in possession of contraband substances. Two independent witnesses namely, Kiran Kumar Rai and Krishna Kumar Gautam both r/o Pipaley were gathered at the PO.

Accordingly, an option was given to them u/s 24 (1) of SADA, 2006 and Sec. 50 of NDPS Act, 1985 for personal search wherein they preferred to be searched in presence of Gazetted Officer. Service of PI Niraj Khatiwada, SHO, Jorethang PS was availed for the said purpose wherein he arrived at the spot after some time. The above-named persons were searched in the presence of GO and two independent witnesses wherein following items were recovered from their bodily possession: -

- Recovered from Sonam Tashi Tamang: -
 - 32 nos of loose blue capsules marked Windlas wrapped in white ruled paper (Exhibit A)
 - Brown Colour wallet containing cash amounting to Rs. 355/-, and one read colour lighter. (Exhibit B)
- Recovered from Niraj Rai: -
 - 59 nos. loose blue capsules marked Windlas wrapped in white transparent plastic. (Exhibit C)
 - INR amounting to Rs. 1850/-, 2 nos ATM Card. (Exhibit D)

The above-mentioned exhibits were seized, packed, sealed and labelled in the immediate presence of Gazetted Officer and two independent witnesses.

Further, the Black Colour Yamaha MT15 motorcycle Bearing registration no. SK 04 P 9786 of Niraj Rai was also seized as case exhibit.

LNK Neehnag Subba also reported that accused Sonam Tashi Tamang had thrown some unknown object below the road. Accordingly, search was conducted at the said area wherein one white ruled paper pouch containing 70 nos. of

loose blue capsules marked Windlas was recovered (exhibit E). The marking (TAYALS) in the top right corner of ruled paper is identical to the markings of the ruled paper seized from the bodily possession of Sonam Tashi Tamang. The same were seized, packed, sealed and labelled in the immediate presence of Gazetted Officer and two independent witnesses.

On 26.06.2022 at 1330 hrs, SI Rinzing Dorjee Lepcha, Duty Officer had received telephonic information stating that Wagon R car had met with an accident near Tanki Dara, Zoom, District Soreng, Sikkim. As directed, self proceeded towards the said spot for enquiry wherein it was found that a Wagon R Taxi Car bearing registration no. SK 01 TA 0348 had tumbled down the road approx. 60 feet today at around 1320 hrs. There were 4 occupants in the car including the driver namely, 1. Driver Ajay Kumar Thakur, r/o Vajra, Gangtok, Sikkim, 2. Mangal Sanbhag, r/o Mumbai, Maharashtra, 3. Bhakti Lad, r/o Mumbai, Maharashtra, and 4. Mamta Lad, r/o Mumbai, Maharashtra.
