Sir,

As per your direction, self along with LNK-Deepak Pokhrel of Singtam PS raided the rented house one Zaved Alam of Golitar Singtam on 26/5/2021 at around 2100 hrs, on receipt of source information that alleged Zaved Alam is carrying out business of

contraband substances from his rented premises for quick and easy money selling it to the prospective buyers.

On reaching, Golitar, Singtam, East Sikkim alleged Zaved Alam was intercepted at the front of his shop. I then immediately secured the presence of two independent witnesses viz. Buddha Biswakarma and Aoyoush Giri and then the alleged Zaved Alam was apprised in presence of above mentioned witnesses giving him option for his body search to be conducted in presence of any Magistrate or any Gazette Officer wherein the alleged person opted to be searched in presence of any gazette officer. Thereafter, I telephonically contacted SDPO/Rangpo for his presence during search and seizure procedure. On his arrival a written requisition was given to him and the same was duly acknowledged by him. Thereafter, body search memo was prepared in r/o of self and LNK-Deepak Pokhrel and then the body search of the alleged person was conducted in the presence of GO and above mentioned witnesses. Accordingly, house search memorandum of alleged Zaved Alam was prepared in the presence of GO and above mentioned witnesses. It is pertinent to note that the house search warrant in r/o alleged person's house could not be obtained from the competent authority as there was every possibility of accused person disposing the contraband substances if delayed in taking action. The house search led to the recovery of one black colour plastic pouch containing three nos. of black colour plastic pouch, 2 pouches containing 131 nos. and 224 nos. of loose blue colour capsules printed Winspasmol and 04 strips of Nitrosun 10 tablets (each strip containing 20 tablets in it) totaling 80 tablets having batch no: AC02694A, Mfg. dtd 11/2020, Exp. dtd 05/2023. The recovered suspected contraband substances were found concealed beneath the wooden couch of alleged person's room. Accordingly, recovered suspected contraband substances were photographed, seized, packed and sealed in the presence of GO and above mentioned independent witnesses.

Hence, request for necessary legal action against the above named alleged person.
