First Information contents (प्रथम सूचना तथ्य):

That on 06/08/2022 at around 2030hrs when I was at Malli checkpoint conducting checking of incoming and outgoing vehicles and persons I stopped a vehicle b/n SK 04 J 0329 coming from West Bengal side for routine checking. While my staffs were checking the luggage loaded inside the vehicle I asked the driver Yogesh Sundas, age 36 yrs, s/o Gopal Sundas, n/o Tink Chisopani, District Namchi, a/p Kazitar, Namchi (later identified) to get down from the vehicle and checked in and around the drivers seat as a part of routine duty. Thereafter I asked the driver to open the green coloured camouflage printed sling bag that he was carrying wherein he had kept a wallet in the middle compartment. When I asked him to open the rear compartment I witnessed 3 phials of Windias Winspasmo Forte capsules having 8 capsules each totaling to 24 capsules and 1 used phial of Windias Winspasmo Forte capsules having 4 capsules. Since the driver failed to furnish a medical prescription for the recovered items, I immediately secured two independent witnesses namely Kamrul Haque and Garja Man Rai for search procedure in anticipation that the driver might have concealed some more contraband substances in his body or the vehicle. Before conducting the search of the above named person I offered myself to be searched first and proceeded with the search as per the provisions laid down u/s 24(2) SADA as it was not possible to take the driver before a Magistrate due odd hours. However upon search nothing could be recovered besides the contraband substances that were recovered from his sling bag. After the search was completed I seized, packed and sealed the following items in presence of the above mentioned witnesses:

- 1.3 phials of Windias Winspasmo Forte capsules having 8 capsules each totaling to 24 capsules having batch no. WPS22008, mfg date Feb 2022 and exp date Jan 2024
- 2.1 used phial of Windias Winspasmo Forte capsules having 4 capsules having batch no. WPS22008, mfg date Feb 2022 and exp date Jan 2024
- 3.1 brown coloured wallet of Being Human containing Rs. 5,960/-, 1 Driving Licence, Aadhar Card and Namchi Local Taxi Drivers Association membership card each belonging to Yogesh Sundas
- 4.1 green coloured camouflage printed sling bag belonging to Yogesh Sundas
