Sir, Ref. to G.D entry No. Chungthang CP/PS, dated: 20.11.2022, as directed I, the undersigned conducted an enquiry on the RTA at near Taramchu Cafeteria, Taramchu and I'm submitting my enquiry report as under-That on 20.11.2022 biker namely Tapas Kumar Guha, 31yrs, s/o Nemo Guha, along with pillion rider namely Jhulan Rorai, w/o Tapas Kumar Guha, 28 yrs both resident of Nadia, West Bengal were heading towards Lachen from Gangtok riding their motorbike i.e. Suzuki Gixxer bearing registration No. WB52AA6655 being driven by Tapas Kumar Guha and on reaching near Taramchu Cafeteria, Taramchu along Chungthang-Lachen road at around 1800 hours the motor bike went off the road and fell down approx. 20 ft. from the road thereby causing severe injuries to the both alleged biker and the pillion rider. The alleged biker has sustained fracture on left forearm while the pillion rider has sustained injuries on head. It was found that the both the injured riders were rescued by the drivers of passing vehicles and were evacuated to Chungthang PHC for medical attention wherein both have been referred to District Hospital, Mangan for better medical management. Therefore, I am submitting my enquiry report for necessary legal action against the alleged biker Tapas Kumar Guha under relevant sections of law.
