Subject: FIR against (1) Tshering Bhutia (CLC, Youth Convener of SKM Party, Temi namphing) (2) Pradeep Tamang, r/o 11th Mile, Barmok (3) Bimal Gurung, r/o Reshep, (4) L.B Basnett, r/o Bekchung, (5) Durga Bdr Chettri, r/o Pabong (6) Phurba Tamang, r/o 11 th Mile, Barmok, (7) Igmee Bhutia, r/o Beriom and (8) Phurba Bhutia, for physically assault, attempt to murder, molestation and house trespass.

Respected Sir,

I Arun Limboo, s/o Buddha Bir Limboo, r/o Namphing, Daring, South Sikkim, belong to Schedule Tribe, on behalf of my younger sister namely, Sushmita Limboo and my sister in law namely Tshering Doma Tamang, and for myself, would like to lodge FIR against the above persons for trespass, physically assaulting, trying to kill me and molesting my younger sister, and assaulting my younger sister in law under relevant provisions of IPC and provisions of the Schedule castes and Tribes (Prevention of Atrocities Act) 1989.

The facts and circumstances of the case are hereunder

1) That today on 06/07/2021 around 11 AM, the above named persons (1) Tshering Bhutia (CLC, Youth Convener of SKM Party, Temi Namphing) (2) Pradeep tamang, r/o 11th Mile, Barmok (3) Bimal Gurung, r/o Reshep, (4) L.B Basnett, r/o Bekchung, (5) Durga Bdr Chettri, r/o Pabong (6) Phurba Tamang, r/o 11th Mile, Barmok, (7) Igmee Bhutia, r/o Barmok and (8) Phurba Bhutia came to my house and they all started abusing me verbally and they all physically assaulted me brutally and tried to kill me inside my house. And one of the above accused person, namely Tshering Bhutia dragged me out of my house and they all started assaulting and beating me with punches and blow on my body and on my left ear and trying to kill me.

2) That after beating and assaulting me, one of the accused persons namely, Tshering Bhutia (CLC Youth Convener of SKM Party, Temi Namphing) had molested my younger sister Sushmita Limboo and also kicked on the left hand of my sister in law namely Tshering Doma Tamang. The said accused person namely Tshering Bhutia touched my younger sister inappropriately and molested her.

3) That above incident was heard by passerby and neighbors. Passerby and neighbors came to rescue me and my younger sister and my sister in law, due to which, the above accused persons manage to run away, at that time, one of the above persons namely Tshering Bhutia (CLC, Youth Convener of SKM Party, Temi Namphing) said to me that they will again come to beat me and my family members with their other friends. It is submitted that I am traumatized by the above incidents and having severe pain on my body and left ear due to which, I am unable to come alone to this police station to lodge this FIR.

In view of the above facts and circumstances, it is humbly requested to register case against the above said accused persons under the provisions of IPC and provisions of the Schedule Castes and Tribes (Prevention of Atrocities) Act, 1989
