Sir,

This is to inform you that as per your order I visited Melli Checkpost wherein I witnessed the suspect Dirgan Chettri detained at the Checkpost by the duty personnel. Upon preliminary enquiry I learnt that the aforementioned person who identified himself as Dirgan Chettri, 23 yrs, s/o Kamal Prasad Chettri, r/o Sumbuk, District Namchi, was traveling in a vehicle br/no. SK 04 J 0053 (Savari) driven by the driver Sahadhar Chaudhary, Ct. Laxmi Chettri who was deployed at the Checkpost while checking incoming and outgoing vehicles at the main gate, stopped the above mentioned vehicle. Accordingly, as a part of routine drill when he started questioning the driver and other occupants present inside the vehicle, the above mentioned person who was seated on the front seat next to the driver behaved in a suspicious manner which created doubt in the mind of duty personnel of some wrongdoing. The duty personnel then checked a white plastic carry bag which was kept besides him wherein substantial quantity of brown coloured powdery pouches suspected to be brown sugar was found.

Sir, as per your order I conducted the body search of the suspect as per the provision laid down u/s 42 of NDPS Act, 1985, in presence of witnesses namely (i) Shrawan Cintury and (ii) Dil Bahadur Dahal after offering myself to be searched first. During search 13 nos. of transparent plastic pouches containing brown coloured powdery substance suspected to be brown sugar wrapped in a light white plastic pouches collectively weighing 14.71 gms were recovered. The pouches were packed inside a white envelope and were kept inside the said plastic carry bag along with his aadhar card.

The same were seized, packed and sealed in presence of the aforementioned witnesses.



12. First information contents (प्रथम सूचना तथ्य):

That on 09/06/2022 at 1105 hrs, I received a message over WT set from NK Dhan Kumar Tamang deployed at Melli CP stating that while he was conducting checking of incoming and outgoing vehicles and people at the checkpoint he intercepted one person who identified himself as Nima Dorjee Tamang along with some loose blue coloured capsules suspected to be contraband. Consequently I proceeded to checkpoint and witnessed the accused person guarded by the duty personnels. As such, I secured two independent witnesses namely Gopal Subbia and Shrawan Gintury and proceeded with the search procedure as per the provision laid down U/S 24(2) SADA 2006. Considering the dignity of the suspect, and since it was raining the search of the person was conducted inside Melli Checkpost in presence of the aforementioned witnesses which led to the recovery of the following items: 1.3 black coloured plastic pouches containing 183, 132 and 233 numbers of blue coloured loose capsules each written WINDLAS WINSPASMO FORTE totaling to 548 capsules 2.3 phials of Nitrosun 10 tablets having 10 tablets each (batch no. DFC4703A, mfg. date 12/2021, exp. Date 11/2024) totaling to 30 tablets wrapped in black coloured plastic. 3.1 cutout strip of Nitrosun 10 tablets having 4 tablets in total Upon recovery of above mentioned articles, Nima Dorjee Tamang failed to provide any medical prescription to support the possession of contraband substance recovered. Thus the items recovered were seized, sealed and packed at the PC in presence of above named witnesses. On the basis of above information Melli PS Case No. 13/2022 dated 09/06/2022 u/s 7/14 of SADA, 2006 the sec 9(1)(c) of SAD (Amendment) Act 2017 is registered against Nima Dorjee Tamang and the case is endorsed to Si Prashant Rai for investigation.

That on 21/06/2022 at 1800 hrs, while I was conducting checking of incoming and outgoing vehicles and people at the check post I intercepted one individual named Nima Tahering Sherpa who was travelling from Silegun to Rivangla in a vehicle b/n EK 04 J 0856 (Sewah). Since the aforementioned person behaved in an unusual manner when he was checked by the duty personnel as per my order, his act created a doubt in my mind of some wrongdoing. Consequently, I intervened and secured two independent witnesses namely Lakpa Tamang and Bipab Kamakar and proceeded with the search procedure as per the provision laid down U/S 100 Cr.P.C. During the search 6 nos. of green coloured plastic pouches containing brown coloured powder suspected to be brown sugar collectively weighing 10.39 gms were found concealed inside the left shoe worn by the suspect. Upon recovery of aforementioned articles from the suspect it were seized, sealed and packed at the PO in presence of above named witnesses. On the basis of above information Melli PS Case No. 14/2022 dated 21/06/2022 u/s 21 of NOPS Act, 1985 is registered against Nima Tahering Sherpa and the case is entrusted to SI Prashant Rai for investigation.

Sir,  
That as per your order I the undersigned visited Melli Check post wherein I witnessed the suspect identified as Kumar Sarki, 25yrs, s/o Harka Bdr Sarki, r/o Majhigaon, Jorethang detained at the check post by the duty personnel. The suspect was travelling from Siliguri to Jorethang in a taxi b/n SK 04 J 0840 (Bolero) along with five other persons including the driver. Consequently, I apprised the suspect about the information received and secured two independent witnesses namely Abhimanyu Rawat (driver of said vehicle) and Bittu Thakur (occupant) for proceeding with the search as per the provision laid u/s 100 CrPC considering the odd hours. I offered search of my person before proceeding with the search. The suspect upon witnessing me approaching for search got aggressive and threw the plastic pouch to nearby fountain which he had concealed inside his underwear. Thereafter he tried to flee from the scene during which he physically manhandled me and LNK Jigmeela Bhutia in a desperate attempt to escape. It took herculean effort to take control over him before proceeding with the search. After binding down the suspect I along with the above named witnesses checked the fountain and recovered the plastic pouch thrown by him. On checking the said plastic pouch, loose blue coloured capsules along with white and black coloured plastic pouches containing brown coloured powdery substance suspected to be brown sugar were found concealed inside it. Accordingly the items recovered were counted where loose blue capsules printed Windlas Winspasm Forte amounted to 58 numbers in total and plastic pouches containing brown coloured powdery substance suspected to be brown sugar collectively weighted to 16.13 gms in total. As such the items recovered were seized, packed and sealed in presence of the witnesses. However the signature of the suspect could not obtained in any of the documents or the packed exhibit as he refused to do so.  
On the basis of above information Melli PS case no. 15/2022 dated: 22/06/2022 u/s 21 NDPS Act 1985 r/w sec 7/14 SADA 2006 r/w sec 9(1)(b) SAD (Amendment) Act 2017 r/w sec 353/186 IPC is registered against Kumar Sarki and the case is endorsed to SI Kessang Gyatso Bhutia for further investigation.
