This is to inform you that on 25th Nov 2022, with my friend Anup Rai I was purchasing paan at paan shop of MD Bhaiya in Daragoan, Tadong two people dragged me from the shop to an alley way and assaulted me with heavy objects causing severe injury to my head and body parts. Anup Rai also received injury of similar nature to his body. As that time I was returning from a marriage. Subsequently, while returning home after the incidence the same persons also assaulted my friend Anup Rai while returning home by way laying him and badly injured him. I learnt that one of the assaulters name is Shekher, a well known bad character of the area. Stern and furious action maybe taken against these perpetrators and justice meted out.
