Sr,
On the morning of 25th March 2021, I left for Siliguri to do shopping for my sheep which is at my own residence. The same morning I took money from my money pouch where I also keep my gold jewellery. After taking out money I kept the pouch containing one bracelet and one necklace of above 10 tolas of gold inside the wooden box and locked it. On the evening of 26th March 2021, I returned back home and slept without checking the box and almirah. On the morning of 27th March 2021, i.e. today morning when I opened the same box to keep my cash, I realised that the pouch containing gold jewellery was missing. With their search for it all around my house and asked friends and relatives about its whereabouts, we did not find it anywhere. So concluded that it might be stolen, we couldn't suspect anyone because the particular room was locked most of the time. The said box containing the gold items was also locked. The key is locked and kept inside the room. Sometimes hung up, under the bed sheet or sometimes on the top of the almirah in the room.

I request you kindly do an enquiry to nab the unknown thief so that the stolen gold items are brought back. We entire family rely on your enquiry and we will provide full support in your enquiry.
