Subject: FIR

Madam, That on 29/04/2021 as per the information received from SHO Temi PS, PI Anupa Gunning I reached the spot i.e. Tikol Bumick near Horticulture College South Sikkim wherein it was learnt that while attending a complaint made against Bishal Chettri of Bumick, South Sikkim, Lax Dudul Bhurtia who had been detailed for attending the complaint had come to know regarding the peddling of brown sugar by one Asith Lutel of Tikol Bumick South Sikkim. The said Bishal Chettri had willingly given his consent on nabbing the peddler. Thereafter, when he asked for delivery of brown sugar to Asith Lutel, he was told to collect the same from above his house i.e. Tikol Bumick near Horticulture College, South Sikkim after which a police personnel in civil cloth and witness Kesar Singh Chettri had been sent after Bishal Chettri. However, before the suspect Asith Lutel could be rounded up, he had already handed over a Zip pouch containing 9 small packets of light brown coloured powder i.e. brown sugar to Bishal Chettri.

Thereafter, as there were no any IOs present at PS other than SHO Temi PS, I conducted the seizure the recovered brown sugar handed over to Bishal Chettri by Asith Lutel which weighed 4.550 gms in presence of two independent witnesses namely Kesar Singh Chettri and Palkash Sharma an arrival of PI Suresh Pradhan, SHO Rangpo PS who had been intimated to give his presence for making seizure. Further more, one peculiar figo car bearing no SK 04 P 0461 belonging to the suspect Asith Lutel was also searched during which cash totalling Rs. 6800/- was recovered from the dashboard and one small silver glass packed in a ply brand were recovered from underneath the front-passenger seat which were also seized in presence of aforementioned witnesses as the suspect could not provide the source of the recovered cash.
