R/s Sir/Madam,

With deep regret and concern we want to inform you that an agitated mob comprising of 12-15 men, entered the work premises of ADIT-2 location of our project site yesterday, 15.11.2021, around 12.45 pm and halted the work. Our security person deployed at location, Mr. Shiva Chetti was physically assaulted by one of the individual from the mob, whereas others threatened our workers not to work.

The workers were too intimidated to report the matter clearly and exact details reached to the management today morning. The assaulters supposedly belong to neighboring villages of project area.

You are requested to kindly look into the matter and take necessary action in this regard at the earliest as project works are suffering badly due to this.




