As directed, undersigned along Police team visited the said accident spot at Linkay Ratay khola at Rikyap and conducted enquiry. During enquiry, it was learnt that the Alto 800 Taxi vehicle bearing Registration No. SK01T 5149 driven by Nima Dorjay Lepcha, 31 years s/o late Kawasing Lepcha r/o 5th mile Tadong along with one passenger namely Hang Limboo plying towards Gangtok Side from Parkha had veered off the road approx. 150 ft from the road side. The driver and passenger who had sustained minor injuries were safely rescued by the locals and evacuated to Pakyong PHC for treatment. The accident was occurred at around 2230 hours on 08.06.2022 at Linkey Ratay khola, Rikyap Pakyong District wherein the above mentioned vehicle had sustained major damaged.

The sequence of events leading to the fraud is as follows:

I received a call at 6.30 P.M on 22/6/2022 from the following nos. (1) 9749406279 (2) 78110479921, (3) 9123739893

I was duly informed that my electricity bill was pending and I needed to pay the due amount to avoid immediate disconnection. I was also asked to confirm the above information by calling another number.

- This I did and thereafter I was instructed to install the QUICK SUPPORT APP.
- After installing the above app, I noticed that Rs. 50,000/- was debited from my account.
- The message indicating the above was deleted subsequently
- Upon informing the above number that the recharge did not happen, I was asked for my A.T.M number and informed by the caller that he would look into the matter
- Upon checking my account status this morning on the 23/06/ 2022 I noted that an amount totaling upto Rs. 99,950/- (Rs Ninety nine thousand nine hundred fifty) had been siphoned off 2 times.

(One transaction for 50,000/- and another for Rs 49,950/-)
