Subject: Enquiry Report.

Sir,

Today i.e 12/10/2021 I was deployed for bazar patrolling duty along with HG Kalzong Bhutia. During my duty hours at around 0500 hours I received an information about the collision of two vehicles near Pakka Pool. On the receipt of information, I visited the spot for verification. On reaching the place of occurrence about 300 metres ahead of Pakka Pool along NH 710 I found one Bolero Pickup Br/No. SK 04D 1162 going towards Jorethang had collided with truck Br/No. WB 73E 9806 coming towards Melli. Due to the impact of collision Pickup vehicle got stuck on the edge of the road whereas the truck was placed on the middle of the road. On detail examination of the spot and looking into the broken glass particles of the vehicle windshield and the positioning of the truck I learnt that the driver of the truck was driving his vehicle on the wrong side as the truck had crossed white middle line (marker) used for separating the lane. The driver of the truck was also driving his vehicle wearing slippers. Further at the time of accident the truck was found driven by Sumit Biswakarma r/o Kitam, South Sikkim and Bolero Pickup was found driven by Man Kumar Tamang r/o Mabong Segang, West Sikkim who was accompanied by occupant Naresh Rai of Sisney, West Sikkim at the time of accident.
