

Subject: FIR

Sir,
That on 14/08/2021, in view of 75TH Independence Day while I was conducting vehicle checking at Melli checkpost, I received a source information at around 2200 hrs about a driver of vehicle b/n SK 04 J 0546 (TATA SUMO GOLD) along with his friend carrying controlled substances to have entered the checkpost and parked the vehicle near the composite building of checkpost. On the receipt of said information I intercepted the vehicle along with the driver Amber Manger, 40 yrs, S/o Lt Birtaman Manger, r/o Kateng, South Sikkim (Later identified) and his friend Jeereld Rai, 21 yrs, s/o Jordan Rai, r/o Kazitar, Namchi, South Sikkim (Later identified). Accordingly, I secured two independent witnesses namely Jogen Rai and Kamal Prasad and thoroughly checked the vehicle as per the provision laid down u/s 100 CrPC wherein I recovered one 'Tiranga' printed carry bag on the carrier of vehicle. On checking the said carry bag, I found one brown colour carton which contain following mentioned articles:

- (i) A black plastic pouch containing 20 bottles of "Maharex" brand cough syrup, having batch number TBHU0890, Mfg. date 07/2021, Exp. date 06/2023, marked as exhibit 'A'
- (ii) A black plastic pouch containing 22 bottles of "Maharex" brand cough syrup, having batch number TBHU0890, Mfg. date 07/2021, Exp. date 06/2023, marked as exhibit 'B'
- (iii) A black plastic pouch containing 142 loose blue coloured capsules printed ' SPASMAXX MAX' marked as exhibit 'C'
- (iv) A black plastic pouch containing 140 loose blue coloured capsules printed ' SPASMAXX MAX' marked as exhibit 'D'
- (v) A black plastic pouch containing 04 Phials of Nirtosun-10 tablets totalling 40 numbers having batch no DFBO244A, Mfg. date 12/2020, Exp. date 07/2023, marked as exhibit 'E'.

Upon recovery of the said items the driver and his friend failed to produce a valid medical prescription when asked to. As such the recovered contraband substances were then seized, sealed and packed in presence of aforementioned witnesses at the spot along with the vehicle involved, its ignition key, insurance certificate and Driving Licence of the driver Amber Thapa.
