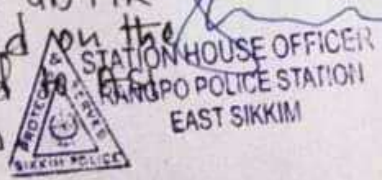

Sir,  
That on 27.04.2021 at 1540 hrs, on the basis of a credible source information received by SHO, Rangpo PS, stating that one vehicle bearing registration number SK08P/1945 was travelling from Rangpo towards Ranipool carrying controlled substances, the undersigned alongwith PC Staff, CT Dawa Tamang was directed by SHO Rangpo PS to intercept the said vehicle and conduct search of the same. The vehicle bearing registration number SK08P/1945 was intercepted at Majhitar, opposite Himalayan Pharmacy college at 1600 hours with the help of L/NK Bikash Sunar. The driver who identified himself as Nitesh Dhakal, 24 yrs, s/o Bishnu Dhakal, r/o Khamdong, East Sikkim was the lone occupant in the vehicle. The undersigned secured two independent witnesses namely I) **Bishwa Gurung, 30 yrs, s/o Prem Bdr. Gurung, r/o Majhitar, East Sikkim and II) Karma Sonam Bhutia, 31 yrs, s/o Karma Loday Bhutia, r/o Majhitar, East Sikkim**. The above mentioned alleged suspect was given an option u/s 24(1) of SADA 2006, wherein he opted to be searched by a Gazetted Officer. Accordingly, the undersigned requested SDPO/Rangpo, ASP Dilip Kumar Tamang over WT set to witness the search & seizure of the alleged person. On arrival of ASP Dilip Kumar Tamang at the spot, I offered myself to be searched by witnesses in person duly preparing search memorandum and proceeded to search the suspect and the said vehicle. No any controlled Substances were recovered from his personnel possession. However, search of the vehicle SK08P/1945 led to the recovery of following articles as under:

- 1) 12 files of Blue coloured capsules (Spasmoproxyvon plus) each file contain 24 capsules except one file containing 21 capsules (03 Nos. of capsules used) having batch No. WAA1010 Mfg date 03/2021 Exp date 02/2023
- 2) 35 bottles of Phencyrex cough syrup having batch No. 061220SMB1 Mfg date Dec 2020 Exp date Nov 2022 which were packed in 07 different black coloured polythene with 05 bottles of cough syrup in each polythene, kept in multicolour carry bag marked as Sonali and concealed inside the dickey of vehicle b/r no Sk08P/1945 driven by the alleged person Nitesh Dhakal. Each bottle of cough syrup containing 100 ML.
- 3) 04 bottles of Ownrex cough syrup having batch No. 061120SH2 Mfg date NOV 2020 Exp date Oct 2022 which were packed in black colour polythene and kept in multicolour carry marked as Sonali and concealed inside the dickey vehicle No Sk08P 1945 driven by the alleged person Nitesh Dhakal. Each bottles containing 100 ML.
- 4) Hyundai Venue bearing registration No. SK08P 1945 registered in the name of Nitesh Dhakal and ignition key- 01 each.
- 5) Registration Certificate of vehicle bearing registration no. SK08P/1945
- 6) Insurance Certificate of vehicle bearing registration no. SK08P/1945
- 7) ID card of Nitesh Dhakal issued by Govt of Sikkim
- 8) Driving license of Nitesh Dhakal
- 9) One Carry bag and 09 nos of Black colour polythene

Since, the alleged person was not able to produce any valid license under the Drugs and Cosmetics Act, 1940 or Sikkim Trade License Act and the prescription of the qualified medical practitioner. Hence, the same were seized u/s 102 Cr.PC for further needful action in presence of above named independent witnesses and gazetted officer. The seized articles were photographed, packed and sealed in presence of two independent witnesses. Hence, in light of above facts you are hereby requested for further necessary legal action against accused, Nitesh Dhakal, 24 yrs, s/o Bishnu Dhakal, r/o Khamdong, East Sikkim
