Subject: First Information Report.

That today on 18/02/2021 at 1100 hrs a credible information was received stating that one Toyota Innova Crysta vehicle bearing registration no: SK01/Z/0643 had proceeded from Chisopani to Jorethang under suspicious circumstances and suspected to contain controlled substances. Accordingly, the undersigned intercepted the said vehicle at Shankey Bhir near Karfactor, Jorethang-Namchi road driven by (i) Shivijan Subba, 29yrs, s/o Bijay Subba, r/o Chisopani, S/Sikkim with five other occupants namely (ii) Dhan Bdr. Pradhan, 20yrs, s/o Santa Bdr. Pradhan, r/o Chisopani, S/Sikkim, (iii) Dilli Ram Lohar, 23yrs, s/o Lt. Harkadas Lohar, r/o Jorethang, S/Sikkim and (iv) Pratik Bishwakarma, 23yrs, s/o Nar Bdr. Bishwakaram, r/o Dhar goan, Zoom, W/Sikkim, (v) Kalpana Limboo, 31 years, w/o Shivijan Subba, r/o Chisopani, S/Sikkim, (vi) Purnima Rai, aged 17 years, d/o Lt. Tirtha Rai, r/o Chisopani S/Sikkim. Since, the above mentioned persons were suspected to be in possession of controlled substances, I secured two independent witnesses named (i) Atish Gurung, 24yrs, s/o Uttam Gurung, r/o

Jorethang, S/Sikkim and (ii) Wongden Bomzon, 30yrs, s/o Sandesh Bomzon, r/o Jorethang, S/Sikkim. Thereafter, the alleged suspects were given an option u/s 24 of SADA, 2006 regarding whether they wished to be searched before the Magistrate or a Gazetted Officer, wherein they opted to be searched in presence of a Magistrate. Accordingly, Sub Divisional Magistrate, Jorethang was intimated through special messenger to be present at the spot for search and seizure procedure and on his arrival, I offered myself to be searched in person by the suspected persons in presence of the Magistrate and the witnesses and then proceeded with the search of the afore-mentioned suspects, wherein no incriminating substances were recovered from their body search. Subsequently, the afore-mentioned vehicle bearing registration no: SK01/Z/0643 was searched in presence of the Magistrate and witnesses, wherein following substances were found concealed beneath the second seat of the said vehicle:

- a) Loose blue coloured capsules totalling 1754 (One thousand seven hundred and fifty four) suspected to be Spasmoproxyvon written WINDLAS, WINSPASMO in a blue coloured plastic bag that was wrapped in a purple carry bag.
- b) 01 foil containing ten capsules suspected to be Spasmoproxyvon written WINDLAS, WINSPASMO with batch no: WPS19026, Mfg date: Sep/2019, Exp date: Aug/2021,
- c) One wooden plank measuring approx. 02ft and 01 inch long that was concealed beneath the third seat of the said vehicle,
- d) Registration certificate of involved vehicle valid till Nov/2021,
- e) Insurance certificate of involved vehicle valid till 08/02/22.

Since, the aforementioned alleged persons were not able to produce any valid license under the Drugs and Cosmetics Act, 1940 or Sikkim Trade License Act nor prescription of any qualified medical practitioner, the same were seized along-with involved vehicle b/r no: SK01/Z/0643 u/s 102 Cr PC for further legal proceeding in presence of above mentioned independent witnesses. The seized exhibits were photographed, packed and sealed in presence of independent witnesses.

On recovery of the above mentioned controlled/contraband substances Jorethang PS FIR no: 09/2021, dated: 18/02/2021, u/s 22/27 of NDPS Act, 1985 r/w 34 IPC 1860 r/w 7/9/14 of SADA, 2006, r/w 9 (i)(c) and 9(4) of SAD Amendment Act, 2017 was registered against above named alleged persons mentioned in Serial No.(i),(ii),(iii),(iv),(v) on Suo -Moto basis and the case is endorsed to SI Lata Bardewa for detailed investigation.
