At this noted hrs, received a telephonic information from one Passang Nangyal Sherpa, Age-41 yrs, S/O-Lingmoo South Sikkim stating that on the same day at around 1800 hrs, his son Mingma Sherpa, Age-12 yrs had committed suicide by way of hanging with the help of nylon rope in chicken coop, located at Lingmoo South Sikkim.
