Subject: **First Information Report.**

Sir,
This is to inform you that on 23.02.2021 at around 2155 hrs, while I was carrying routine vehicle checking at Melli Check Post, I came across one vehicle bearing No. SK 05 P 1841 (Bolero) driven by one Bimal Pradhan, age 36 years, s/o Lt. Kul Bdr. Pradhan, r/o Namchi, Bazaar, South Sikkim. When I started enquiring as to where he had come from and if he has carried anything in the vehicle he started getting nervous. The suspicious behaviour on the part of the driver created doubt about him being in possession of controlled substances. Accordingly, without further delay I secured two independent witnesses namely i) Dinesh Prajapati, 33 years, s/o Lt. Deo Narayan Prajapati, r/o Melli Bazaar, South Sikkim and ii) Ajay Kumar Byahut, 36 years, s/o Lt. Prem Shanker Byahut, r/o Melli Bazaar, South Sikkim and conducted search of vehicle as per the provision laid down u/s 100 Cr.PC. However, prior to search, the driver Bimal Pradhan was appraised in writing about the circumstances of search. I also offered myself to be searched by the witnesses. Subsequently, after duly following legal formalities search of the vehicle was conducted in presence of abovenamed witnesses. During search **44 bottles of CEFREX Cough Syrup, having batch No. TBHT2302, Mfg. date 12/2020, Exp. Date 11/2022, marked as exhibit "A" concealed inside army green coloured (KIPLING) bag, marked as exhibit "B" was found on the second seat of the vehicle. Similarly one Grey coloured (FABION) sling bag, marked as exhibit "C" containing documents of involved vehicle including (certificate of registration, driving licence of driver Bimal Pradhan and duplicate copy of insurance certificate) packed in a red bag was recovered from the front seat of the vehicle.** On the recovery of abovementioned items the alleged person was asked to furnish the prescription and since he failed to produce the same the items recovered were seized u/s 102 CrPC for further necessary action in presence of above named independent witnesses. The exhibits seized were then sealed packed and photographed at the checkpost in presence of above-mentioned witnesses.

Hence, I am submitting FIR for further necessary action against the aforementioned driver.
