That, this evening i.e., on 05/05/2021, when I was conducting checking of vehicle/ Nakabandi at Akarbridge, Nayabazar, West Sikkim assisted by LNK Hasta Maya Rai, LNK Birbal Pradhan, LNK Angshi Hang Subba alongwith IRBn. Personnel, a vehicle bearing registration No. **SK 04 J 0678** (Silver colour Mahindra Maxx) coming from Jorethang was intercepted around 1840hrs on suspicious of carrying contraband/controlled substances.

I, therefore availed the presence of Dy.S.P Mahendra Pradhan SDPO/Soreng as conceded by the suspect drive named Manoj Tamang Golay for search. At the relevant time, Dy.S.P Mahendra Pradhan, SDPO/Soreng was at Pipaley on his way back to Soreng from Gyalshing.

In presence of Dy.S.P Mahendra Pradhan, SDPO/Soreng and independent witnesses namely; (i) Shri, Binod Pradhan and (ii), Shri, Suk Ram Tamang conducted the search of vehicle as mentioned above, including body search of suspect driver of Manoj Tamang Golay.

During the search, the following contraband/controlled substances and cash amounting Rs. 12,350/- are recovered from the inner panel above left and right rear tyre of above mentioned vehicle and side pocket of pant of the suspect driver.
