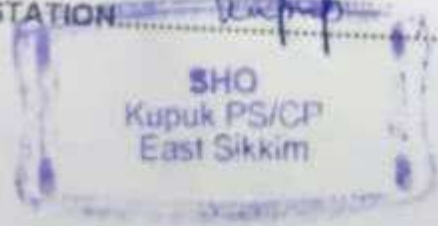

Kupuk ward was declared as containment zone vide reference
no: 300/DC(E)/2021 dated 21.06.2021 (copy attached). It was
learnt from the social media posts that one medical team Compr.
Sing of Dr. Mechung and his team members has entered in
Containment zone on 23.06.2021 obtaining pass from ADGP. Check
post on the promise of distribution medical supplies.

The incident Commander was not aware of this entry allowed
to Dr. Mechung Bhutia and his team from the office of the ADGP
checkpost. Also the concerned medical officer was also not made
aware by Dr. Mechung Bhutia and his team regarding the
distribution of medical supplies. This entry is clear violation
of point 3 of the above mentioned containment zone order.
Report of incident Commander, Shri Thendup Lepcha BDO Nandoh is
attached herewith for kind information.

You are requested to register a complaint against this un-
authorized entry in containment zone and take suitable action.
