Subject: First Information Report

Sir,

As per your direction self-visited old check post Rangpo and found one Bus bearing registration No. WB-73E-8569 parked on the roadside at Rangpo check post was well guarded by the duty personnel LNK Tek Bdr. Chhetri of check post. On enquiry, it was found that the suspected passengers identified as 1) Raju Biswakarma, 35yrs, s/o Gopal Biswakarma, r/o Assam Lingey, Ranipool and 2) Pramod Darnal, 24 years s/o Bhagat Darnal r/o Namin, Ranipool were found seated in seat nos. 22, 23 of the aforementioned bus in a suspicious manner. Thereafter, under the provision of section 100/165 CrPC, self-secured two independent witnesses namely 1) Bishal Joshi, 42 yrs, s/o Man Bdr. Joshi, r/o Singtam and 2) Kumar Tamang, 55 yrs s/o Prem Kumar Tamang r/o Devi Danga, Siliguri (Bus driver). The alleged suspects were given option u/s 24(1) of SADA 2006, however they did not want presence of any Gazetted officer or magistrate during the search, hence I being a Gazetted Officer myself, offered myself to be searched by witnesses in person/witnesses duly preparing search memorandum and proceeded to search the suspects and their belongings as per the provision of section 24(2) of SADA Act 2006. No any controlled substances were recovered on the personal search of the alleged suspects however on search of the orange/black bag pack with NIKE logo belonging to the suspects Raju Biswakarma and Pramod Darnal which was found kept on the bag shelf/compartament above the seats of the aforementioned suspects, led to recovery and seizure of the contrabands and its packaging as under:

1568 nos of Winspasmo Forte capsules in 196 files of 08 capsule each, having batch No. WPS22017, Mfg date MAR/22 and Exp date: FEB/24- marked as A10 nos of Nitrazepam tablets (Nitrosun-10) in 01 file of 10 tablet each having batch No: DFD1396A, Mfg date 04/2022 and Exp date: 03/ 2025 - marked as B30 nos of Nitrazepam tablets (NITROME-10) in 03 files of 10 tablet each having batch No: AT5954, Mfg date 01/2022 and Exp date: 12/2024 - marked as C Orange/black bag pack with NIKE logo along with 12 nos. black plastic polythene, Shoe cover karton white colour carry bag. All above mentioned exhibits (A, B, C) were found packed in 12 nos. of black plastic polythene which were kept inside a Shoe cover cartoon and placed inside a white colour carry bag which was then concealed inside an orange /black bag pack with NIKE logo belonging to the aforementioned suspects. At the time of search seizure procedure, both the alleged persons viz. Pramod Darnal Raju Biswakarma also admitted to the above mentioned witnesses that they had both travelled to Siliguri together and brought the above seized controlled substances. Since, the alleged persons were not able to produce any valid license under the Drugs and Cosmetics Act, 1940 or Sikkim Trade License Act nor the prescription of the qualified medical practitioner. Hence, the same were seized u/s 102 CrPC. for further needful action in presence of above named independent witnesses. The seized articles were photographed, packed and sealed in the same orange /black bag pack with NIKE logo in presence of above mentioned independent witnesses.

Hence, in light of above facts you are requested for further necessary legal action against alleged Raju Biswakarma, 35yrs, s/o Gopal Biswakarma, r/o Assam Lingey, Ranipool and Pramod Darnal, 24 years s/o Bhagat Darnal r/o Namin, Ranipool.


