That on 05/06/2021 at about 1650 hrs while I and ASI Navin Tamang were on our way back from Sadam after conducting patrolling we witnessed two individuals who were later identified as Santa Bir Tamang and Navin Rai standing near a bike b/n SK 01 P 8753 in the middle of the road at Chalisey near YBL fatak. Since unnecessary movement of people and vehicle are restricted during the period of lockdown ASI Navin Tamang got down from our vehicle and started questioning as to where they are going to and why haven't they put on a mask to which Navin Rai replied that they are on their way back home after buying meat. Since ASI Navin Tamang was not satisfied with their answer he asked him to show the bike documents that is when the other person Santa Bir Tamang who was seemingly drunk started getting aggressive and started shouting unparliamentary words. He started saying that he is a driver of Yuksom Breweries Limited and is returning back from his work. Since the answers given by the above named persons did not match I got down from the vehicle and asked him to show me the ID Card that could prove that he is a driver of Yuksom Breweries Limited and is actually returning back from his work to which he started challenging me and pushed me. As he was drunk, he became totally uncontrollable, thus I and ASI Navin Tamang caught hold of him but he punched on my face and tried to escape from the scene. Consequently, I held him by his wrist that is when he physically assaulted me and ASI Navin Tamang with kicks and punches. I immediately called for help and thus after the arrival of reinforcement I along with ASI Navin Tamang and the alleged person Santa Bir Tamang went to Melli PHC for medical examination.




