
Thereafter we got engaged in rescuing susham Pradhan taking him to hospital for medical treatment, However on the way he died.

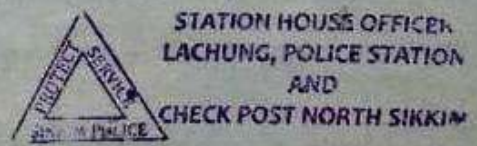
