Sir, on Dt. 03/12/2021, at around 8 pm Mr. Ugen Bhutia, hit my sister at their residence at 7th Mile, Barapathing, and she was unconscious, as has been badly torture by her husband, as he hit on her eye, on her chest and one and one leg has been facture badly and we have taken her to the STNM hospital and she is admitted on emergency ward right now.

Sir, I therefore would like to request your good-self to kindly register my case and take necessary action against Mr. Ugen Bhutia as per the law and if anything happen to my sister then his husband will be fully responsible for the cause.
