Madam,

That on 09/09/2021 at around 1612 hrs SHO/NBPS received telephonic information from L/NK Birbal Pradhan detailed at Ramam Check Post stating that a vehicle b/r no. SK 01 PA 3539 carrying 4 persons had come to Ramam CP from WB side for entry into Sikkim wherein he suspected that the persons boarding the vehicle may be in possession of contraband substances.

As directed by SHO/NBPS, I immediately rushed to Ramam CP for enquiry. Upon reaching Ramam CP, I found that a vehicle b/r no. SK 01 PA 3539 driven by one Tirtha Kumar Bhujel, r/o Soreng, West Sikkim was parked near Ramam CP entry gate boarded by 3 more persons namely, 1. Diwakar Rai, 2. Sushant Rai, and 3. I Zeliang all resident of Soreng, West Sikkim. I examined them and strongly suspected to be in possession of contraband substances. Accordingly, an option was given to them u/s 24 (1) of SADA, 2006 for search of person and vehicle in presence of two independent witnesses namely Pravesh Gupta and Vikram Bishwakarma both r/o Nayabazar, West Sikkim wherein they preferred to be searched in presence of Gazetted Officer. Service of Shri, Mahindra Pradhan, SDPO/Soreng was availed who arrived at Ramam Checkpost around 1800 hrs. The above-named suspected persons was therefore searched in the presence of Shri, Mahindra Pradhan, SDPO/ Soreng and two independent witnesses wherein following contraband/psychotropic substances were recovered from the possession (left front pocket) of one Tirtha Kumar Bhujel, age 29 yrs, s/o Lt. nar Bahadur Bhujel, r/o Daragaon, Soreng, West Sikkim:-

1. White colour tablets suspected to be Nitrosun 10 tablets packed in black colour polythene: 43 tablets
2. Loose Windlas Winspasma Forte capsules packed in black colour polythene. 119 nos. of capsules.

The above-mentioned exhibits were seized, packed, sealed and labelled in the immediate presence of Shri, Mahindra Pradhan, SDPO/ Soreng and two independent witnesses.

The vehicle bearing reg. no. SK 01 PA 3539 was also searched wherein one foldable knife and one ninja sword along with black scabbard was found in the vehicle. Accordingly, the said items along with the vehicle b/r no. SK 01 PA 3539 was also seized as case exhibits in presence of two independent witnesses.

The other occupants 1. Diwakar Rai, 2. Sushant Rai, and 3. I Zeliang were handed over to their legal guardian since nothing was recovered from their possession.




