This is to inform you that on 13th April 2021 at 9.30 PM I Zangden Topka, 36 yrs, wife Suman Chakrabarti Bhutia s/o Rahang Namkung South Sikkim had gone to fetch water in my Courtyard and while returning, I could feel two hands holding my body from behind. He picked me up and took me to the basement of my house which was pitch dark, but I saw the face of Tshering Thendup Bhutia, s/o Pasing Tshering Bhutia who is my neighbour due to the light in my Veranda. I tried to release his hands from my body but could not as I was feeling too weak. I cried and called out for help but my husband was not there as he had gone to work at long day. Tshering Thendup Bhutia pushed me against the wall and undressed me by pulling up elastic cloth.

As I belong to Poor family and I was very scared as Tshering Thundup Bhudia is my neighbour He took advantage of me being alone with two small minor kids and raped me on 13th April Night. I went back to my maternal family at Bukaha, North Sikkim and shared my ordeal with my Sisters I could not tell it to my husband for the fear that he would involve himself in fight with Tshering Thundup Bhudia

I have come to report the F.I.R against Tshering Thundup Bhudia for raping me. Therefore you are requested to take necessary legal action against him
